Youth, Parents and Teachers Join National Week of Action to End Pushout in Georgia Schools

90% OR NOTHING

Graduation March on Georgia

Georgia – The Gwinnett Coalition to Dismantle the School to Prison Pipeline (Gwinnett SToPP), in partnership with ACLU of Georgia, Georgia Safe Schools Coalition, Interfaith Children's Movement (ICM), and Lambda Legal are bringing their voices to the 4th Annual Dignity in Schools Campaign National Week of Action on School Pushout with a Graduation March on Georgia, Wednesday, October 2, 2013, 4pm-7pm. The goal of the march is to raise graduation rate awareness and educational expectations for students of color and students with disabilities in Georgia. The Graduation March on Georgia, will begin at Neal Blvd and Scenic Hwy in Lawrenceville and conclude with a rally at the Lawrenceville Historic Square.

During the week of September 28 to October 5, members of the Dignity in Schools Campaign (DSC) will hold rallies, marches, forums and trainings aimed at calling on states and school districts to prioritize funding for hiring counselors, school psychologists, community intervention workers and the implementation and training of teachers and school personnel in positive discipline practices like Restorative Justice and Positive Behavior Intervention and Supports (PBIS). Members of the DSC will also be calling on their school districts to address disparities in punishment and referrals to criminal justice, which disproportionately impact low-income youth, youth of color, LGBTQ, and students with disabilities.

The 2011 graduation rates for African American students in Georgia is 59.8% with a 2013 goal set by the Georgia Department of Education of 66.5%. Gwinnett SToPP is issuing a call to action to raise graduation rate expectations to 90%. Students with disabilities, gay, transgender students, and Hispanic students suffer the same low expectations in Georgia's and Gwinnett's educational policy. Gwinnett SToPP believes that bringing together a coalition of like-minded student and adult groups will encourage elected officials to question why it is necessary to lower their educational expectations for youth of color and students with disabilities when crafting and examining the impact of educational policy in Georgia.

For decades thousands of Georgia students of color and students with disabilities have been quietly pushed into underperforming disciplinary alternative schools² and psycho educational facilities.³ At the same time, these same students are grossly excluded from general, gifted and advanced classrooms all across Georgia.⁴ Now is the time to bring those educational policies forward for closer examination.

While we all applaud Governor Deal's juvenile justice reform initiative, the Governor, Superintendent Barge and the State Board of Education must engage the reformation of long-standing educational policies and practices contributing to the overrepresentation of minorities and students with disabilities in our youth incarceration facilities and their under-representation in rigorous classroom settings.
